Statement and Rationale	It is the law under the Child and Family Services Act that if a Driver, Operator or Consortium Staff have reasonable grounds to suspect that a child is or may be in need of protection, it is his/her duty to report to the appropriate Children’s Aid Society.

Procedure	<p>Report the suspicion and the information upon which it is based to an appropriate Children's Aid Society.</p> <p>Examples of the situations that must be reported are set out below. However, officials of the appropriate Children’s Aid Society will be the ones to conduct any and all investigations. Drivers, Bus Operators and Consortium staff have a duty to report only.</p> <ul style="list-style-type: none"> <li>i) The child has suffered, or there is a risk that the child is likely to suffer, physical harm, inflicted by the person having charge of the child.</li> <li>ii) The child has been, or there is a risk that the child is likely to be sexually molested or sexually exploited, by the person having charge of the child or by another person where the person having charge of the child knows or should know of the possibility of sexual molestation or sexual exploitation and fails to protect the child.</li> <li>iii) The child requires medical treatment to cure, prevent or alleviate physical harm or suffering and the child's parent or the person having charge of the child does not provide, or refuses or is unavailable or unable to consent to, the treatment.</li> <li>iv) The child has suffered emotional harm, demonstrated by serious anxiety, depression, withdrawal, self-destructive or aggressive behaviour, or delayed development, and there are reasonable grounds to believe that the emotional harm suffered by the child results from the actions, failure to act or pattern of neglect on the part of the</li> </ul>
